Project Description: The project is designed to extend the life of the landfill by using existing space within the landfill design that is not being used for refuse disposal. This interior expansion of the landfill will not extend beyond the currently permitted disposal area boundary of the Fink Road Landfill. The objective of the In-Fill Project is to provide approximately 10 - 20 years of additional capacity. The current

landfill design life is estimated to extend to 2023. An additional objective is to increase the landfill height to provide a final closure design that is more conducive to the surrounding terrain than the currently approved landfill closure configuration. Other objectives of the project are to accomplish the In-Fill Project without increasing the daily tonnage, vehicle trips, or change in the classification of the non-hazardous municipal solid waste materials currently accepted.
