Stanislaus County Parks & Recreation to Celebrate Bonita Pool Reopening with Ribbon-Cutting Ceremony Tomorrow, September 13

Crows Landing, Calif. – The Stanislaus County Parks & Recreation Department is excited to invite the public to the ribbon-cutting and official grand reopening of the newly renovated Bonita Pool at 11 a.m. tomorrow, Saturday, September 13, 2025. The pool is located on the corner of 4th/I Street in the community of Crows Landing, and will serve as a vital recreational resource for residents of all ages.

The Bonita Pool Project represents a significant investment in the community, delivering long-awaited improvements to this vital neighborhood park. The project includes a new swimming pool, restrooms, equipment room, concession stand, site enhancements, and improved accessibility throughout the facility. These improvements reflect Stanislaus County's ongoing commitment to building community services by enhancing parks.

To celebrate the reopening, Parks and Recreation is partnering with the Stanislaus County Police Activities League (PAL) to offer the community *free swim weekends* throughout September from 12:00 p.m. to 5:00 p.m.

"Bonita Pool will serve as a source of pride for Crows Landing and provide lasting benefits for the entire Westside."
