The facility is routinely maintained, bathrooms cleaned, lawns mowed

- Club camping is still closed due to COVID restrictions/Fire
- Grover has begun clearing and pruning damaged trees from the fire. They will be removing approximately 300 trees
- The Bathroom at the camp was Vandalized. All electrical and plumbing was stolen from the building. The theft was reported to the Sheriff's dep.

Lagrange OHV:

- Trail work, erosion control, fencing, and facility cleanup are done routinely
- Lagrange OHV will Host Valentine's Day Stuck fest in February
- The Park is open for Day use and camping
- Lagrange OHV now accepts online reservations for our developed sites on the upper camping area. Fifteen campsites are available to be reserved. Included in the reserved area: potable water, fire pit/BBQ, table, and concrete RV pad

Basso Fishing Access/TFA:

- Both Fishing Access are Maintained and cleaned on a regular basis
- Basso continues to stay busy
- TFA is currently only open for Walk-In Recreation as the state has closed down Turlock Lake as they find a new Vendor

LaGrange Park:

- The Park and restroom are cleaned and maintained regularly
- Regularly maintain lawns and trees at the Old Schoolhouse

Woodward Reservoir:

- Visitation is up slightly from last year
- Revenue totals for January 2022 were \$155,251.25 compared to January 2021 totals of \$84,590.00 for an increase of \$70661.25, mostly from reservations
- The new Reservation /POS system is finally to the point of workability. Many thanks to folks on my staff who have been working diligently on this. (Miguel Yanez, Ray McCabe, and Sherry Angel)
- Hackberry Flat restroom is set to get upgraded to LED lighting in February
- The windmill at Bayview pt. had a new concrete pad installed around the wellhead
- Concrete repairs were made on the pad at campsite 87 from a section being cut out for repair of a mainline water leak at the end of last season
- We extended the waterfowl season to include the Junior hunt and the Veteran's hunt
- Weed abatement continues on the roadsides and in the camping areas
- Fish and Wildlife have been monitoring the invasive rodent Nutria at various places around the reservoir. So far, none have been detected

County Centers/County Parks

- Fairview Park The shade cover for the playground has been cut open due to vandalism
- Riverdale Park and Fishing Access Homeless persons continue to damage the park's shoreline access gate to get to the river bank and have set up many tents, other structures, and even a barge on the river. This is happing on both County property as well as behind the old transfer station property. The park supervisor recently visited the site and was met by more than one aggressive dog and called animal control. The Park Supervisor met with the County Outreach team, who was just leaving, and said they offered the County's service and at least there were no kids there this time. As the Park Supervisor was taking pictures of what had been created he found that a small child was living there. We continue to work with the Sheriff's Dept. for enforcement, but just like Mono Park, this seems to be a reoccurring issue that is consuming a great deal of Parks staff time
- Mono Park Homeless persons continue to occupy this location. Parks staff and Sheriff's Deputies served eviction notices and made everyone vacate the park, but they move back in within a short time. Parks staff are encountering needles at this location daily. Homeless people have also threatened parks staff while they were trying to perform their duties on several occasions but don't have hours to wait around for a Deputy to

respond each time. We continue to work with the Sheriff's Dept. for enforcement, but like Riverdale Park, this seems to be a reoccurring issue that consumes a great deal of Parks staff time.

- Oregon Park A vehicle ran into the chain-link fence that encircles this location and damaged approx. 85ft of fencing. Someone also dumped a load of Greenwaste in the street next to the park on Tioga. See attached
- Broadway/Salida Park Median–
- Broadway/Salida Park Salida Little League is gearing up for a very full season this year. As in years past, they have requested to practice T-Ball in the Park as it is adjacent to the Baseball Field owned by the Salida School district.
- Burbank Park –
- Parklawn Park Someone used a hammer or similar object to break holes in the slides at this location. They do not make this slide in sections anymore. That would have allowed us to only replace the one damaged section. You now have to replace the whole slide. Quote came back at just over \$13K plus the cost in labor for Parks staff to pull the old one and install the new one. Multiple times this winter, people have done "donuts" on the turf and have driven the park's length, causing a lot of turf damage. See attached
- Empire Park A hazardous tree at this location is scheduled to be removed. See attached
- Empire Tot lot –
- Laird Park The homeless's public dumping and camping remains a weekly issue at this location. An RV staying here recently caught fire and burned to the ground. This hazard remained here for a month before it was finally removed by vehicle abatement. The restroom doors that were previously damaged have been replaced. Someone ran into the fencing surrounding the turf area and again graffitied the restroom. See attached

Shilo Fishing Access -

UCP – The basin at the end of this location is being used as a regular public dumping site. Parks removed 16,000lbs of waste from this location just a couple of months ago, and already two water heaters, and a fiberglass shower enclosure have been dumped here. Someone also damaged a bench (which has been removed) and burned and broke out the concrete pad that a picnic table sits on. See attached.

E. COMMISSION COMMENTS

ACTIONS & REPORTER

1. Commissioner Keller inquired about lights for kids playing soccer at Fairview Park. Jaclyn Dwyer, Director of Parks and Recreation let the commission know that Parks Manager James Pursley has received several quotes and will move forward with purchasing the 4 that come with solar lights. Darlynn Haas will get an update on the status of those lights. In the same conversation, Commissioner Keller asked for thoughts on adding a plaque for the late Commissioner Sanchez. Jaclyn advised that we can check with James to see if we have to pour concrete for the lights, but something will be figured out to honor Commissioner Sanchez and his effort with Fairview Park.

2. Jaclyn provided an update on Mono Park and the unhoused population. The ongoing problem has been faced not only by Parks and Recreation but also the Sheriff's Office, Community Services Agency, and Public Works because of the taskforce put together by the County to end illegal dumping and graffiti. There are about 15 people from different departments involved in the taskforce that are trying to figure out a solution for the park. Community Services Agency has made contact with individuals and these people refuse services. The goal is not to close the park – County Counsel is looking at language from Placer County to see if we are able to pass ordinances that the Sheriff's Department is able to enforce to the unhoused population at Mono Park. The hope is to offer the population to either move along or accept services provided by the County, but the plan is still in beginning stages. The Placer County documents can serve as an example, but they are a general law county, so we would not be able to implement everything. Updates can come as more definitive solutions are created. Commissioner Grant thanked the department for their hard work and efforts in not closing the park down.

Jaclyn Dwyer Austin Grant

3. Commissioner Grant inquired about revitalizing basketball courts. Q: Is the County able to upgrade current basketball courts to be more modern? A: We can go through the County parks and see what parks are due for upgrade and then divide into sections. It would depend on location and what type of materials can be used in the upgrades. Some materials may not be ideal for Oregon Park but could work for Segesta Park. We would likely want to make a contract of at least two or three parks for most optimal pricing.

Austin Grant Jaclyn Dwyer

This request ties into what Darlynn Haas and Jaclyn Dwyer are working on related to an overall maintenance and replacement plan for all parks. Requests have been made to the Chief Executive Office for a separate deferred maintenance fund for Parks and Recreation. We are currently reliant on the County to provide funds or receiving grants in order to make upgrades.

In addition to this information, Jaclyn explained that the California Parks and Recreation has a tool where you can put in an address and it tells you the age group,

income level, and other statistics that can help in the assessment of materials and needs of the parks in particular areas. Jaclyn will send California Parks and Recreation site.

4. Jaclyn shared that she and Darlynn sat in on a call for Smart City Parks, which is a big push to install solar panels, wifi, and other upgrades to provide lower socioeconomic areas the ability to have these resources.

Commissioner Keller asked about the vandalism proof restrooms.
 Q: How are the vandalism proof restrooms coming along?
 A: We are still designing Oregon Park, but it is in the works. Oregon Park design numbers came in way over budget, so some cuts had to be made to fit costs. There will be a new playground and adult exercise equipment as well. The Portland Loo bathroom is being installed.
