MINUTES

PRESENT: Please see attached sign-in sheet.

- I. Meeting called to order by Nancy Bronstein at 3:38 p.m. Roundtable introductions were made. Training to be provided in July to new members of the commission and new department representatives.
- II. Commission Business
 - Previous Minutes There was no quorum of members present, therefore, approval of the minutes from the April meeting will be held over until the August meeting.
 - Correspondence No correspondence.
- III. EEO Training
 - Training Update
 - Effective Communications Class was held on May 28, 2014 with 14 attendees. Next class will be held September 10, 2014.
 - Preventing Harassment, Discrimination and Retaliation (non-mandatory training) Class was held on May 2, 2014 with 24 attendees. Next in July? Check with Brandi. Next class will be held September 5, 2014.
 - Mandatory Sexual Harassment Class was held on March 6, 2014 with 74 attendees. The next class will be held June 19, 2014 with 117 employees scheduled to attend.
 - Full day Disability Management training will be held on August 13, 2014 with an additional half day training scheduled for September 3rd. This class will be moved into the Supervisory Training Academy in the future.
- IV. EEO Complaints Please send all investigations completed at the department level to Barbara to log and scan into the CEO's records. There are a lot of investigations going on. Disability discrimination / failure to interact complaints have gone up. Sexual harassment claims going down.
 - County Complaints Nancy provided verbal update on County complaints.
 - Departmental Complaints Nancy provided verbal update on departmental complaints.
- V. Non-Standing Items
 - Bylaw Review In reviewing the documentation that was found, there are no bylaws but lots of
 other background information. The Commission doesn't want a lot of onerous bylaws but does
 want to update the documentation that we have. One fact which emerged was that the
 commission shall select its own chairperson. There is currently no chair selected. As there is no
 quorum today, we could take nominations today or address the issue in its entirety at the next
 meeting. Jeremiah nominated Carmen Morad as Chair and Leslie Beggs as Vice Chair. Need to

determine what the role of the chair will be. Getting rid of term limitations was suggested with the comment that longevity benefits the commission. Craft language to allow for a 3 year term and then to BOS to reappoint. We'll come back next time for vote. There is extra time to review the document as there is no quorum. Commission members and employee representatives to come to the meeting in August with any suggestions. After a cursory review, the following changes were indicated:

- Change Affirmative Action to EEO, change quorum number to fit Brown Act guideline (majority). Service and resource group – need clarification. Improve county's representation of equal rights.
- In number 3 body to review we do Equal Rights report and will update language to reflect what is done.
- > In number 4 affect attitudes update language.
- Review policies update wording
- On number 7 for recruitments, it would be good for EEO commissioners to participate on recruitment panels. Department EEO staff often participate as panelists.
- > Majority of filled seats versus majority of the 7 members.
- Selection of Chairperson for Equal Rights Commission Discussed under Bylaw Review
- Dale Butler Award / Ceremony Recap of what the event is and a discussion of when to have the awards ceremony. September 29 through October 3 is Diversity Week. A lot of planning for diversity week already occurring. October 17 is the date selected by the group for the award ceremony.
- Department Award Naming It was decided that the Department Award be named in honor of Dionicio Cruz. Exact wording to be determined.
- Diversity Week Each County Center is taking a day for their events. CEO staff will provide a schedule to all of the commissioners and BOS once it is established.
