AGENDA

I. Call to Order

Evelyn Gardner, Learning & Organizational Development Manager, called meeting to order meeting at 3:34 pm.

Commissioners' Altman, Beggs, Biesemeier and Kaur are present at the beginning of the meeting. Commissioner Williams arrived at 4:07 pm.

Evelyn Gardner welcomed Rhonda Biesemeier and Harjit Kaur our two new commissioners.

Rhonda Biesemeier worked for Stanislaus County for 37 years in the Benefits Department. She retired from county 15 years ago. Rhonda served on the StanCERA Retirement Board. She chose to be on this commission because she likes to be involved with community activities.

Harjit Kaur currently works as the Pro Bono Program Managing Attorney at Equal Rights Advocates providing critically needed legal assistance/advocacy in Title IX processes. She also advocates for gender justice in the workplace, ensuring justice for victims of sexual assault, harassment and discrimination.

All attendees were invited to introduced themselves around the room.

II. Commission Business

- Previous Minutes
 - June 15, 2022 It was decided not to motion to approve the minutes because our new Commissioners were not in place at the time of the previous meeting. The approval of the minutes will be postponed until the next meeting.
- Correspondence There are no correspondence from any of the Commissioners.

III. EEO Training

- Training Update
 - Training Report 1,228 employees completed the County's Mandatory Sexual Harassment Training between 06/14/2022 and 08/15/2022. This is about 1/3 of the County's active workforce.
 - Additional EEO related trainings are scheduled for fall 2022. There is not as much training in the summer season. There will be some additional supervisor training coming up soon.
 - There have been some problems accessing our online Harassment Prevention training. Evelyn has helped solve some login issues. Anyone having problems, please contact Evelyn.
 - Crucial Conversations Training coming in October and December 2022.

 CEO Human Relations staff were provided training by US EEOC. The course explained LGBTQI+ inclusion concepts and how to make the workplace more welcoming. US EEOC's Training Institute is a good resource for more information and trainings on EEO topics. Please continue to reach out to Tamara or Evelyn with ideas on training opportunities.

IV. EEO Complaints

County and Departmental

- It has been approximately 18 months since we have had Shaw Law EEO Investigation Training. By a show of hands, there are 12 people who are interested in having this training for themselves or their department.
- The Stanislaus County Equal Rights Complaint Log was included with the Commissioner's packets.

V. Community Outreach

- Report Out
 - Bernie Licata, Manager IV, said that the County will be conducting interviews Friday for the Marketing & Talent Acquisition Manager – Outreach. This position will go into the community to try and recruit applicants for our current openings. This will include schools and colleges. The County feels that this will lead to a greater pool of candidates. If anyone has any ideas about adding more tools for recruiting candidates for the County's open positions, please contact the County's recruitment team.
 - Frankie Juenamann, Management Consultant, was asked about the DEI Manager recruitment. Frankie let us know that the flyer is still getting finalized, and as of today, the position has not been posted. The HR Department is looking to partner with the Community to fill this position.
 - Jamie Croft, HR Management at HSA, announced that HSA is recruiting for a Health Equity Manager.
 - Evelyn let attendees know that on Saturday, August 27, 2022, there will be a 5K Walk/Run to Raise Awareness on Fatal Drug Overdoses and Poisonings.
 - There were no other announcements. All attendees are urged to let Evelyn know any other upcoming events. All information will be shared.

VI. Non-Standing Items

- Evelyn thanked all who have spread the word about Commissioner Recruitment. We have filled five out of the seven positions. We are really trying to fill the additional two seats. He added that honoring someone for their contributions will be reciprocal, and that it is not a difficult task to acknowledge someone. He would like to see many nominations.
 - Commissioner Williams said that attendees of past Awards presentations thought it was a great event to celebrate people in their organizations who have gone above and beyond.
