The remaining "Consent" items for which there are no voice objections will be handled by a single action of the Commission.

ANY MEMBER OF THE AUDIENCE DESIRING TO ADDRESS THE PLANNING COMMISSION REGARDING A MATTER ON THE AGENDA: While the Planning Commission welcomes and encourages participation in the Commission meetings, it would be appreciated if comments are limited to five minutes so that everyone may be heard.

New agenda items will not be heard after 11:00 p.m. If agenda item is not fully discussed by 12:30 a.m., it will be continued at the discretion of the Chair.

## \*CONSENT ITEMS

- \*A. <u>PARCEL MAP APPLICATION NO. PLN2017-0112 JEFF & LISA MCPHEE</u> Request to subdivide a nine gross acre parcel into three parcels of three± gross acres each in the Rural Residential (R-A) zoning district. The property is located at 12919 Lancaster Road, east of Stanislaus River Drive, in the Oakdale area. The Planning Commission will consider adoption of a CEQA Mitigated Negative Declaration for the project. APN: 010-012-040. [View Item]
- \*B. <u>TIME EXTENSION FOR VESTING TENTATIVE SUBDIVISION MAP</u> <u>APPLICATION NO. PLN2006-06 - KNIGHTS FERRY OVERLOOK</u> - Request for a one year time extension. The approved Tentative Map subdivided a 33.70 acre parcel into eight lots ranging from 0.50 to 5 acres in size and a 12.03 acre remainder parcel in the A-2-5 (General Agricultural) and HS (Historical Site) zoning districts. The project is located at the southeast corner of Cemetery and Frymire Roads, in the Knights Ferry area. The project is considered Exempt from the California Environmental Quality Act. APNs: 002-044-003 and 002-044-004. [View Item]
- \*C. <u>TIME EXTENSION FOR USE PERMIT APPLICATION NO. PLN2012-0017 –</u> <u>AVILIA AND SONS WASHINGTON ROAD WAREHOUSE</u> – Request for a six month time extension. The Use Permit was approved June 16, 2018, to allow construction of an 180,000 square-foot warehouse building and associated facilities for the receiving, storing, packing, and shipping of agricultural produce on 26± acre portion of a 61.7 acre property, in the A-2-40 (General Agriculture) zoning district. The property is located at 1301 North Washington Road, between Fulkerth Road and West Main Streets, in the Turlock area. The request is considered Exempt from the California Environmental Quality Act. APNs: 023-039-017 & 023-039-018. [View Item]
