A. USE PERMIT AND DEVELOPMENT AGREEMENT APPLICATION NO. PLN2020-0010 – STANCO FAMILY FARMS – Request continuance to May 19, 2022. Request to operate a commercial cannabis cultivation, nursery, and distribution business on a 35.8-acre parcel in the General Agriculture (A-2-40) zoning district. The project proposes to construct eight, 3,920 square foot greenhouses and one 1,500 square-foot warehouse for processing activities. A Development Agreement is included in the project request.
