PLN2022-0020 HALAL BUTCHER SHOP</u> *Requesting an indefinite continuance.* Request to utilize a 4,000 square-foot suite, within an existing 29,040 square-foot warehouse building, for the slaughter of chickens, lambs, and goats on a 1.07± acre parcel in the Industrial (M) zoning district.
