ACCESSORY DWELLING UNIT (A.D.U.) BUILDING FEES

Building Fees estimated for an accessory dwelling unit only. No garage, patio covers, carports etc. included (Includes: Building, Electrical, Plumbing, Mechanical, G.I.S., Building Standards Fund, General Plan Update, One Stop Shop, and Strong Motion Tax)

1000 sq. ft. or less = \$2,625 (this includes up to \$300 in plumbing, mechanical and electrical)

1100 sq. ft. = \$3,300

1200 sq. ft. = \$3,500

County Impact Fees – New Home Sites Only – Replacements Exempt

Unincorporated Area \$10,171 Accessory Dwelling Unit (A.D.U.) \$ 3,061

A.D.U.'s 750 sq. ft. or less are exempt from impact fees
