



## CELL TOWER MODIFICATIONS

These figures are for ESTIMATING purposes only. All fees are subject to change.

**Building Fees** estimated for cell tower modifications that **do not** include additional batteries, generators, structures, antennas or adding height to the tower.

How to use the table below to calculate fees

- 1) Locate the valuation of the project on the table
  - a) The 1<sup>st</sup> amount listed below your valuation in *italics* is the fee that will be due upon initially submitting the project to Stanislaus County.
  - b) The 2<sup>nd</sup> amount listed below your valuation in **bold** is the estimated total amount that will be paid for the permit. The total amount includes the submittal fee and the estimated remaining permit fees due at time of issuance.

Additional departments listed above may require a review of the plans and / or an additional permit if:

- 1) The parcel is in a flood zone
- 2) The cell site has not had an address assigned
- 3) There is a change in height of the tower
- 4) There is a modification, addition or replacement of:
  - a) Batteries
  - b) Generators
  - c) Structures
  - d) Additional Antennas

A Use Permit or Staff Approval Permit may be required from Stanislaus County Planning Department. Please contact the Planning Division directly for any questions on Use Permits or Staff Approvals at 209-525-6330.
