1. CALL TO ORDER AND INTRODUCTIONS

The meeting was called to order at 3:32 p.m. by Chief Probation Officer Mark Ferriera. Members of the group present at the meeting were identified.

2. Public Comment

No members of the public were present.

3. ADOPTION OF MINUTES FROM SEPTEMBER 04, 2024, AND DECEMBER 09, 2024, MEETING

MOTION: Public Defender Jennifer Jennison. SECOND: Public Defender: District Attorney Jeff Laugero. The September 4, 2024, and December 9, 2024 meeting minutes were approved unanimously.

4. DISCUSSION OF THE FIVE-YEAR SPENDING PLAN

Administrative Services Manager Vicki Martin from the Probation Department provided an overview of the CCP Five-Year Spending Plan, which did not include the Governor's budget projections released in January. The Governor's January budget projections indicated only minimal funding growth for FY 2025-2026. Ms. Martin pointed out that without any additional expenditure on the CCP budget and by spending the historical 85% of the allocated revenue, CCP funding can be extended through FY 2028, with a budget deficit anticipated in FY 2029. If spending reaches 100%, the deficit would begin in FY 2027.

District Attorney Jeff Laugero expressed concerns about funding resources and staffing to manage Collaborative Courts and Prop 36. If the budget improves, the District Attorney's Office will have the opportunity to submit a request for CCP funding consideration.

The implementation and challenges of Proposition 36 (Prop 36) were discussed, highlighting the importance of a clear treatment definition under Prop 36, which may cause delays and result in individuals being held in custody. It also addressed issues such as the shortage of certified treatment providers and the need for funding and resources to support the effective implementation of Prop 36. Chief Ferriera mentioned that various organizations, including the Chief Probation Officers of California (CPOC), will present before the California Senate next week to advocate for Prop 36 funding.

The CCP Executive Committee also discussed using CCP funding to cover IST fines and highlighted the need for clarity on the reimbursement process to ensure accurate CCP budgeting. Additionally, the importance of returning unspent CCP fund allocations to the CCP budget was emphasized.

The Probation Department requested flexibility with the "Crime Analyst" line item in the budget. This line item was designed for the Probation Department to contract with the Modesto Police Department for the services of a dedicated Crime Analyst since Fiscal Year 2015. The request is to allow the use of the allocated funding to hire a Crime Analyst for the Day Reporting Center (DRC) as a Probation Department employee, should the position become vacant. The request does not require additional funding.

MOTION: Jeff Laugero. Second: Jennifer Jennison. To approve the Probation Department's use of the allocated funding for the DRC Crime Analyst as a Probation Department employee was approved unanimously.

The CCP Plan is submitted annually for the Board of Supervisors' approval. The CCP Executive Committee discussed the budget situation and, not anticipating that the Governor's May budget revisions would increase the CCP budget, agreed to proceed with the submission of a rollover budget.

MOTION: Chief Brandon Gillespie Second: Jeff Laugero. To present a rollover budget to the Board of Supervisors was approved unanimously.

Chief Ferriera advised that the CCP Plan will most likely be presented to the Board of Supervisors on April 29, 2025.

Mr. Kevin Panyanouvong from Behavioral Health and Recovery Services announced his intent to retire in March.

The meeting adjourned at 4:17 p.m.



BRIEF HISTORY

• April 4th, 2011 - Assembly Bill (AB) 109 was signed, which realigned custodial and community supervision responsibilities for non-serious, non-violent, and non-sex offenders from the state level to the local level.

• AB 109 was enacted primarily to relieve overcrowding in the State Prison system and reinvest resources to support evidence-based practices and programs.

ASSEMBLY BILL 109



AB 109 made the following changes to law:

- · Revised the definition of a felony
- Sentences could be served in County Jail rather than State Prison
- Established that Probation Departments could supervise offenders released from State Prison and County Jail

ASSEMBLY BILL 117

AB 117 – Requires the Executive Community Corrections Partnership (CCP) to recommend a local plan to the County Board of Supervisors annually for approval.

AB

Per the legislation, the CCP
Executive Committee consists of:

- · Chief Probation Officer (Chairperson)
- Sheriff
- · District Attorney
- · Public Defender
- Presiding Judge of the Superior Court or designee
- · A Chief of Police (currently represented by the Modesto Police Department)
- · Behavioral Health and Recovery Services Director*
- * Legislation asked that the Board of Supervisors appoint one department representative from the following: Head of Social Service, Head of Mental Health, or Head of Alcohol and Substance Abuse programs

FUNDING

- Funding is driven by State Sales Tax Revenue
- State base and growth amounts equal a "rolling base" for the next year
- · Based on caseload size, crime and population, and other "special factors," each County is given an allocation to manage the AB 109 population




 This board has approved all 14 prior CCP plans

- One technical adjustment is recommended:
 - Move historically approved funding for one contracted Modesto Police Department Crime Analyst to the Probation Department's "Salaries and Benefits" allocation. This would be a cost-neutral adjustment.



2026 COMMUNITY CORRECTIONS PARTNERSHIP BUDGET




