

1. CALL TO ORDER AND INTRODUCTIONS

The meeting was called to order at 1:33 p.m. by Chief Probation Officer Mark Ferriera. Members of the group introduced themselves.

2. PUBLIC COMMENT

There were no members of the public present.

3. ADOPTION OF MINUTES FROM MARCH 16, 2023, MEETING

MOTION: District Attorney Jeff Laugero. SECOND: Tony Vartan. The minutes from the March 16, 2023, meeting were approved unanimously.

4. ANALYST UPDATE:

Crime Analyst Trisha Birchard shared a PowerPoint presentation detailing the Day Reporting Center programming update from 2013 through June 2023 (the presentation is attached to the minutes). The presentation focused on the following:

- REFERRALS
 - Programming available at the DRC is only available to individuals referred by the assessing Probation Officer or their assigned Probation Officer; multiple program referrals can be received simultaneously.
- OUTCOMES
 - Individuals' attainable results are completed, terminated, or failed to attend.
 - 54% of 81 completions for 2023 were achieved during the first referral period.
 - The Batterer's Treatment 52-week Program has the highest completion rate for the current year, with 33 completions or 41% of 81 individuals referred.

- 75% of individuals referred for programming from 2013 through June 2023 obtained one of the three outcomes attainable.
- Leaders in Community Alternatives (LCA) received the highest percentage of referrals in 2022 and 2023 of the programming offered at the DRC.
- **RECIDIVISM**
 - Recidivism is defined as a conviction/new offense committed within 3 years from the program's end date.
 - Individuals who complete a program are less likely to recidivate than those who failed or did not attend the program.

5. PROGRAM UPDATES:

CARE: CARE Manager Raul Dominguez from the Probation Department shared a PowerPoint presentation detailing the following for the quarter (the presentation is attached to the minutes):

- SERVICES PROVIDED DURING THE 4th QUARTER
- SERVICES PROVIDED FOR YEAR 2023
- CLIENT BOOKINGS
- SUBSTANCE ABUSE DISORDER (SUD) RELATED BOOKINGS
- CLIENT UPDATE:
 - 105 active clients open to CARE during the 4th quarter.
 - 30 clients' cases were managed by CARE 2.0.
 - 5 clients were closed during the 4th quarter; 2 were housed, 1 was connected with a full-service treatment provider, and 2 clients were in the custody of the state hospital.
- RECENT SUCCESSES:

Mr. Dominguez noted that one of the main focuses of CARE is to provide clients with the proper medical care to prevent clients from self-medicating, which could result in death. He identified the services most provided to the CARE community as food, clothing, and medical care, with the highest success rate in SUD.

CARE Manager Raul Dominguez shared the success story of Sara, a CARE client whose story can be seen on the Probation YouTube channel. After years of being homeless and dealing with a substance abuse disorder, today, she is not only drug-free but has also obtained full-time employment and is no longer homeless.

Day Reporting Center:

Division Director Michael Walker provided the following Day Reporting Center (DRC) update:

- There has been an increase in program referrals and completions. The number of clients receiving services has doubled from last year.
- The Tattoo Removal Program has had a great turnout, servicing everyone attending the scheduled events. The Tattoo Removal Program is being widely advertised throughout the community, contributing to the program's success. Mr. Walker reported that 35 individuals had been serviced during the most recent event and 71 total for the 4th quarter. The upcoming tattoo removal event is slated for October 24th.
- The Probation Department participated in several Regional Apprehension Team (RAT) operations, resulting in several arrests and the recovery of firearms. In October, the Probation Department will partner up with the Turlock Police Department and the Modesto Police Department.

Jail: Sgt. Perea reported the following programming update from 2021 to 2023:

- Learning Quest serviced the following:
 - 68 individuals in HSE.
 - 64 individuals in Microsoft Excel.
 - 59 individuals in Microsoft Word.
 - 67 individuals in Seeking Employment.
- Leaders In Community Alternatives Employment Program serviced 54 individuals.
- Nirvana STIC program serviced 19 individuals.
- BHRS serviced 11 in Women of Wisdom, 6 in MRT "Battling Shadows," and 3 in SUD services.
- Child Protective Services provided Child Welfare programming to 8 individuals.
- Additional Programming:
 - 65 Offender Corrections
 - 10 Principles and Values

- 43 Cognitive Awareness
- 11 Landscaping Program
- 7 Welding Program
- 5 Sewing Program
- 1 Fetch Program (Animal Shelter reinstated since COVID-19); 5 are scheduled to start.
- 24 Agricultural Program
 - They currently have chickens and goats; the goats will be used for fire reduction.

District Attorney's Office: Brittany Harker from the District Attorney's Office reported the following:

- 88 Victim restitution notices were provided.
- 1 Notice of restitution was submitted for filing.
- The Probation Department requested information on 66 Criminal Protective Orders.
- The Probation Department received Criminal Protective Order information assistance 53 times.

Public Defenders Office: Reed Wagner from the Public Defender's Office gave the group a recruitment update. Mr. Wagner also advised that they were in the process of initiating a Request for Proposal for the Homeboy Industries Program.

Behavioral Health and Recovery Services (BHRS): BHRS Director Tony Vartan advised the group of their partnership with the Public Defender's Office to create a seamless Collaborative Court process. Meetings are scheduled with the Courts to discuss Rule of Court revisions concerning the Specialty Courts to be able to move forward. Chief Ferriera asked Mr. Vartan if he could please provide information on CARE Court.

BHRS Director advised that CARE Court was an initiative intended to deliver mental health and substance use disorder services to the most severely impaired individuals suffering homelessness or incarceration who are without the treatment they desperately need. He explained that the CARE Court would connect individuals in crisis with a court-ordered CARE Plan that would include a clinically appropriate, community-based set of services and support.

Stanislaus County is one of seven participating counties in the Pilot Program, which all other counties will have to implement by the end of 2024. Terry Withrow expressed being very pleased with the CARE Court, noting that it would save lives.

Leaders in Community Alternatives:

Shayla Prasad introduced herself. She is an Employment Specialist who is assigned to the DRC.

Consuelo Guzman reported the following:

- 49 participants enrolled in CBI-Employment classes at the DRC.
 - Continuing to start new classes every two weeks.
- 7 participants are currently enrolled in a vocational program.
- 16 participants completed a vocational program in the last 90 days.
- 23 participants completed the CBI- Employment curriculum in the last 90 days.
- 13 participants completed and graduated from the LCA program.
- 9 participants completed ART.
- 3 CBI Employment groups are facilitated in custody.
- Ms. Guzman reported a substantial increase in referrals received.

Nirvana:

Michael Bagley reported the following for July 2023 through August 2023:

- 15 Residential Program referrals were received. A total of 9 individuals were admitted into the program; 4 individuals successfully completed; 2 individuals transferred to sober living; 4 individuals were unsuccessful.
- 2 clients were admitted to the Sober Living Program; 1 completed; 1 switched to Medical.
- The STIC Program is operating smoothly, with 3 successful completions at the DRC.
- The REACT STIC program facilitates 3 classes per week. Men's REACT had 1 successful completion; the women's REACT is scheduled to have 2 completions on September 20th.

Dane Holding reported the following for July 2022 through June 2023:

- 127 Residential Program referrals were received. A total of 39 individuals were admitted into the program; 19 individuals successfully completed it, and 20 individuals were unsuccessful.
- 3 clients were admitted to the Sober Living Program; 4 completed and 1 failed.
- The STIC Program had 23 successful completions in the DRC.
- The REACT STIC program had 38 males successfully completed.

6. ANNOUNCEMENTS/COMMENTS:

Terry Withrow noted being pleased with the program reporting. He voiced the need to facilitate residential beds for individuals who are dealing with homelessness and substance use disorders. Dane Holding noted that Nirvana has 36 available beds, noting that the inability to fill the beds contributes significantly to the lack of individuals not showing up. Mr. Vartan advised that in collaboration with Nirvana, Redwood, and SRC, there are currently 516 residential beds. He also mentioned the possibility of an expansion pending a new partnership. The group discussed the importance of engaging and filling the beds and servicing individuals in need to help them get sober and off the streets.

Stephanie Jimenez announced that in addition to CARE's success stories, DRC's success stories can be viewed on the Probation social media channels or YouTube.

Chief Ferriera announced that programming presentations would be on a rotation schedule starting in November, allowing the other CCP-funded agencies to present their CCP-funded program outcomes. The rotation will be as follows:

- BHRS and the Modesto Police Department will be presenting in November.
- The Public Defender and Sheriff's Office will present in March.
- The District Attorney's Office will present in June.

Sgt. Perea asked if available programming was advertised. He suggested using social media to inform clients about the available programs. Nirvana advised that their website has an online chat feature that's had great success. The group had an extensive discussion, bringing awareness to the community about all the available services.


Program Update through June 2023

- Individuals can receive more than one referral at a time.


Referrals Issued

2022





Through June 2023




Individuals Referred



Outcomes

- Outcomes are the result the individual achieved in the program.
- The outcomes are hierarchized:
 - Completed
 - Terminated
 - Failed to Attend
- Just over half (54%) of the eighty-one (81) completions were achieved the first time the individual was referred to the program.
- The program with the most completions, so far this year, is Batterer's treatment for men at 33 completions or 41%.
 - Batterer's Treatment is a 52-week program; thus, these individuals began the program last year.
 - 27% (9) of the individuals that completed Batterer's Treatment did so the first time they were referred.
- Outcomes for 2023 are through June




- Recidivism is defined as:





Q4 Services Provided







1. Call to Order and Introductions

The meeting was called to order at 1:32 p.m. by Chief Probation Officer Mark Ferriera. Members of the group introduced themselves.

Stanislaus County

Community Corrections Partnership (CCP)

3. Modesto Police Department Community Health and Assistance Team (CHAT) Presentation (PowerPoint attached)

The CHAT team currently works 5 days per week. The plan is to have the CHAT team work 7 days per week once MPD has the ability to fill all the CHAT vacancies.

The CCP budget includes a Medi-Cal offset for services rendered.

5. Program Update:

Realignment Manager

Michael Walker, Realignment Manager, Probation Department, reported that services at the Day Reporting Center (DRC) continue to increase. The Batterer's Intervention program includes 15 classes per week, and often, there is a waitlist for this class.

34 people attended the last tattoo removal program. The next tattoo removal program event is December 12, 2023, at the DRC from 1:00 p.m. – 4:30 p.m.

Regional Apprehension Team (RAT) operations continue with Turlock, Modesto, Patterson, and Newman Police Departments.

Preparations for next year's CCP plan will begin in January 2024.

CARE:

Raul Dominguez, CARE Manager from the Probation Department, reported that for the first quarter of FY24, CARE averaged 750 individual contacts. An average of 300 individuals were served per month.

The top three services provided this quarter are still food, clothing, and medical services. The CARE team takes individuals to their appointments, makes sure they get the medication that they need, and when necessary, work with Social Workers in the hospital.

31% of long-standing unhoused individuals are engaging in services.

41% of the long-standing unhoused individuals are willing to take essential services but do not actively engage in a case plan.

27% of long-standing unhoused individuals are refusing all services.

Sheriff's Office:

Program statistics and information were provided from 07/01/23 to 11/29/23. The program statistics and information packet is attached.

District Attorney:

Patricia Sanchez reported the following:

The Victim Services Unit recently increased the number of services to victims. The number of victims who received information for restitution from September 15, 2023, to November 29, 2023, was 117. The number of victims who submitted restitution to the case files was 4. Probation reached out for victim names and information, copies of Criminal Protective Orders (CPOs) and restitution information 157 times during this same period.

Many Victim Advocate positions are funded by grants which are ending in 2024 or are now competitive. The DA's Office is transitioning how they are funding and filling those positions.

Public Defender:

Jennifer Jennison reported the following:

There are 6 full-time Client Support Specialists. They are now staffing the Self-Help Center at the Court 3 days per week.

The Public Defender's Office is collaborating with BHRS and the DA's Office to create the new Court Assessment Team.

Workforce Development:

Doris Foster reported the following:

Since July 1, 2023, Workforce Development has served 124 previously justice-involved individuals. Of these, 24 found employment. The average hourly wage is \$21.41.

Ms. Foster also noted that Workforce Development staff spend a lot of time conducting individual counseling to help individuals overcome some of the barriers to employment.

Nirvana:

Melissa Norvise reported Nirvana's statistics were good. Attached are the Nirvana Drug and Alcohol Treatment Program statistics from August-October 2023.

Learning Quest:

Learning Quest reported that there is a possibility of 12 upcoming graduates.

Announcements:

The presenters scheduled for the next meeting are the Public Defender's Office and the Sheriff's Office.

Overview of CCP Funded BHRS Programming

November 30, 2023

CCP Behavioral Health Services Team (BHST)


In alignment with the Department's Core Treatment Model, this multidisciplinary team provides comprehensive mental health services to adults (ages 18 and older) who, as a result of serious and persistent mental illness, have difficulty maintaining stable residence, experience significant impairment in daily activities, are on Post-Release Community Supervision, experience frequent law enforcement contact, or experience frequent or lengthy psychiatric hospitalization.

Two levels of care are offered within this team, Assertive Community Treatment (ACT) and Intensive Community Support (ICS). Offering different levels of care within one team allows clients to progress through their recovery while staying connected to their known treatment providers.

Services include: 24/7 access to a known service provider, access to supportive service funds, individualized service planning, crisis stabilization alternatives to jail, re-entry support from a state hospital, peer and family support, housing and employment assistance, independent living skills training, mental health rehabilitation, medication support, and linkages to existing community supports.



Detention Services

This team, comprised of mental health clinicians, provides in-custody mental health treatment services to inmates with Serious Mental Illness (SMI). Treatment services are offered as an adjunct to the primary provider of in-custody mental health services, Wellpath. BHRS Detention Services include: assessment, case management, individual therapy and group therapy.

Additionally, the team consists of one in-custody liaison position designed to connect inmates with a SMI to outpatient treatment services upon their release. This includes individuals returning from a state hospital or who are completing their treatment within the JBCT program.



Intensive Outpatient Treatment- Day Reporting Center

This team, comprised of Substance Use Disorder (SUD) certified Behavioral Health Specialists, provides Intensive Outpatient Treatment (IOT) substance use disorder treatment services to individuals on Probation. Services include: intake (including assessment), treatment planning, individual and group counseling, collateral, case management, crisis intervention, patient education, and discharge services.

Additionally, the team consists of one in-custody liaison position designed to connect inmates with a SUD to outpatient treatment services upon their release.



The Court Assessment Team will be dedicated to completing a comprehensive psychosocial mental health assessments as well as substance abuse disorder assessments to identify individuals' level of care and treatment needs. This team will also assist with linking individuals to collaborative court programs as well as outpatient treatment providers throughout the county.


Collaborative Court Behavioral Health Services Team

In alignment with the Department's Core Treatment Model, this multidisciplinary team will provide comprehensive mental health services to adults (ages 18 and older) who, as a result of serious and persistent mental illness, have been court ordered to treatment through Mental Health Court or Diversion proceedings.

Services will be provided at the Full Service Partnership level of care and will utilize the Assertive Community Treatment model of treatment. Services will include: 24/7 access to a known service provider, access to supportive service funds, individualized service planning, crisis stabilization alternatives to jail, peer and family support, housing and employment assistance, independent living skills training, mental health rehabilitation, medication support, and linkages to existing community supports.

Reimagining Policing

- CHAT embodies Modesto Police Department's commitment to an alternative policing response and engagement in our community.




Top 4 Calls for Service

SUMMARY

From the beginning of the Fiscal year to date, Our Programs have been made up of ACCI Packets, BHRS, CPS, Nirvana, LCA, LearningQuest, MJC, Staff Lead Course, and multiple hands-on Vocational courses.

Our Ag program is made up of chickens and goats with hands-on experience training on how to care for the animals and collecting on average 10 dozen eggs a day that supplement IP's breakfast. We have 61 goats now for weed and brush abatement. 7 of them were born on site and inmates assisted with the welfare of the newborn kid goats including bottle-feeding. Over the last 6 months, the goats have cleared 9 sites that help the county with fire control.

From April to the end of Sept, we had a Job Assistance Program where Program staff would assist the IP housed in our React facility. They assist with finding companies they will be hiring at the time of the IP release. The Program staff assists IPs in putting in applications and arranging phone interviews, and in-person interviews. The program has assisted in 5 successful job placements and about 70 interviews.

In October our Programs started MJC classes with 18 students, due to MJC IT issues there were some delays so one of the classes had to be dropped with plans to pick up again after they can get their IT straightened out.

Over the past few months, we have been working with Workforce Development to implement a partnership to get job-related resources while in custody that can be resumed once they are released.

We have 25 volunteers that are with N/A & A/A who come in to offer counseling and celebrate recovery to IP for a total of 12 hours a month in our REACT Facility.
