### **1. Call to Order and Introductions**

Chief Probation Officer Mark Ferriera called the meeting to order at 1:30 p.m., and members of the group introduced themselves.

### **2. Public Comment**

No one provided public comment.

**3. Adoption of the Minutes from the November 14, 2024, meeting.**

MOTION: Jennifer Jennison. SECOND: Mark Ferriera. The minutes from the November 14, 2024, meeting were approved unanimously.

**4. Sheriff's Office CCP Presentation (Presentation is attached)**

Lieutenant Tim Burns from the Sheriff's Office (SO) delivered a PowerPoint presentation that gave an overview of the detention facilities and services offered. The Sheriff's Office partners with various community organizations to provide inmates with vocational training, religious services, job readiness, job skills, and basic education. Forthcoming projects include expanding the welding program, a second phase of electrical training, and launching a window tinting program.

**5. Public Defender's Office CCP Presentation (Presentation is attached)**

Shelli Margarite, Gabriela Verduzco, and Martin Velasco presented a PowerPoint outline of the Public Defender's Client Support Services, which aims to keep clients out of custody by connecting them with needed services and addressing both legal and non-legal consequences of arrest. They also assist with legal mitigation by gathering personal and service-related information to share with attorneys, helping to humanize clients in court. They focus on preventing collateral impacts, such as job or housing loss, by offering care coordination, advocacy, system navigation, case management, peer support, and referrals to services like mental health and substance use treatment. The presentation included the following:

- Client Support Services Unit

**Public Defender's Office:**

Public Defender Jennifer Jennison reported that the client support team has over 850 open cases. Tricia Birchard, Raul Dominguez, and Michael Walker from the Probation Department collaborated with the team, demonstrating their generosity. The team consists of six full-time Client Support Specialists, two part-time staff members, and two full-time social workers. The embedded behavioral health team is two and a half weeks into its operation and is excited about the potential for great work together. The Public Defender's office appreciates the support and collaboration from the Probation Department.

The Public Defender PAC team, a CCP-funded pair, will assist post-release individuals from jail, providing case management, medication connections, and other services. A similar team, funded by the state, will be added to the CARE court to help those at risk of becoming inmates. The team has successfully housed a client in his residence for the first time in 40 years, thanks to the efforts of the client support team.

**6. Program Updates:**

Chief Ferriera referenced a prior discussion regarding the format of program reporting, redirecting the focus toward broader trends, issue identification, and outcomes. Data Analyst Trisha Birchard proposed creating an online platform for stakeholders to centrally submit data, suggesting the use of OneDrive except for BHRS, which does not yet have access to OneDrive.

Trisha Birchard will coordinate with everyone to distribute instructions on accessing the system, logging in, and submitting data, ensuring a smooth transition to the new reporting process.

**Probation Department:**

Deputy Probation Officer Stephanie Jimenez from the Probation Department provided an update regarding the tattoo removal program, including the distribution of a new flyer with upcoming service dates, May 6 and June 17. The most recent event had a strong turnout, with approximately 52 individuals receiving services. While the program initially targeted individuals on probation, it has since expanded to serve the broader community.

Deputy Probation Officer III Erika Ruano reported on three recent Regional Apprehension Team (RAT) operations, conducted in Oakdale, Waterford, and Newman, that resulted in multiple arrests primarily related to firearm-related violations. A RAT operation is scheduled for March 20 in Waterford.

CARE Manager Raul Dominguez reported that in Quarter 2, service numbers remained stable compared to the same period last year, 2,467 this year versus 2,454 last year.

There are currently 103 active clients in CARE: 57 with the Outreach and Engagement Team (1.0 Team) and 46 with case management. This quarter, three individuals were linked to Mental Health Full-Service Partnerships. Two individuals moved into long-term care facilities, and two cases were closed due to a loss of contact, which often indicates that individuals are no longer in the area or have connected to other services.

Mr. Dominguez shared a success story about a woman on the transient offender list who had nearly 20 police contacts in three months. She was quickly given temporary housing and completed assessments, then moved to treatment. Working with the Public Defender's Office, seven municipal code violations were dismissed. She continues in treatment and is doing well.

#### **District Attorney's Office:**

Yvette Ramirez, from the Victim Advocate Services Unit, shared a success story in their efforts to support crime victims, highlighting their recent work with an individual who was orphaned at the age of 10 following the murder of his parents 46 years ago. After one defendant was released on parole and a second was granted parole in January 2024, the advocates assisted him in applying to the California Victim Compensation Board, enabling him to access therapy services at no cost.

#### **Modesto Police Department:**

Captain Chris Adams from the Modesto Police Department reported that the CHAT team has extended a conditional offer to fill its final open position, bringing the team to full staffing with a total of 12 members. The CHAT team has implemented seven-day-a-week coverage, which has been functioning well.

#### **Behavioral Health and Recovery Services (BHRS):**

Chandra Campbell from BHRS reported that the outpatient level of care officially launched in December. Since then, participation has grown quickly. In FY 2023–24, about 80 people were served, with nearly 70 already served this year, showing strong momentum.

The Mental Health Court program is currently supporting 15 participants, having previously been reduced to only one or two for an extended period. Notably, two individuals graduated from the program last month.

Although all treatment teams are currently fully staffed, the Adult System of Care, including the Collaborative Courts treatment teams, continues to be significantly affected by exceptionally high caseloads.

#### **Community Services Agency (CSA):**

CSA Director Christine Huber discussed the Community Services Agency's ongoing monitoring of developments at both the budgetary and state levels, recognizing that many of the programs used to determine eligibility are also employed for billing and related purposes. They are actively monitoring for any potential impacts on Medi-Cal and CalFresh that may arise.

#### **Leaders In Community Alternatives (LCA):**

LCA continues to hold CBI employment and job search groups, as well as ART at the Day Reporting Center and REACT. They are now collaborating with the City of Oakdale, which is hosting new training;

lunch and transportation will be provided. LCA has also started utilizing the program van to provide transportation to participants during their job search.

**Learning Quest:**

Learning Quest Program Manager Vanessa Carmona provided a staffing update, announcing the retirement of Executive Director Karen Williams and introducing Michelle Casper as her successor in the Executive Director role.

Ms. Carmona reported challenges related to testing, both in custody and at the Day Reporting Center (DRC), due to widespread testing anxiety expressed by participants. Learning Quest is exploring the development of a supportive resource, such as a pamphlet or guide, to help address and reduce testing anxiety.

Despite this temporary setback, Learning Quest has seen significant improvement, with a total of 14 graduates from the DRC and in-custody programs. Recent successes include a minimum housing graduate who scored 87 out of 100, as well as several students achieving near-perfect or perfect scores on the HiSET exam.

Chief Ferriera shared a story about newly retired Learning Quest Director Karen Williams, recalling when the Probation Department launched its first Day Reporting Center (DRC) in Salida, operating with minimal funding and no budget for programming. The department partnered with community-based organizations, including Learning Quest, to provide essential services to high-risk probation clients at no cost. The initiative was to create a one-stop shop for supervision and support services, laying the foundation for the current DRC on Hackett Road. He acknowledged that Learning Quest played a key role by offering high school equivalency exam preparation and remains grateful to all of the early partners, especially Karen Williams, whose contributions were vital to the program's success.

**Nirvana:**

Melissa Norvise reported an increase in sober living referrals. She shared a success story about Nirvana's first probation-funded client from 2013, who stayed with Nirvana over the years and ultimately became a house manager. Through his continued dedication and financial discipline, he has recently achieved homeownership and successfully transitioned to his new life. Ms. Norvise also introduced Nirvana, Men's Program Director Wyatt Trammell.

**Stanislaus County Office of Education (SCOE):**

Saundra Day shared that she attended the Modesto Window Tinting Academy graduation ceremony, where six female graduates received their certificates.

**Center for Human Services Agency (CHS):**

CHS Director Gina Machado announced the completion of the Youth and Family Outpatient Behavioral Health Facility, set to open in May 2025. Services will be available to individuals ages 0-25 and their families with mental health and substance use disorders.

**7. Comments:**

Supervisor Terry Withrow addressed the County's decision to terminate its contract with Mr. Michael Baldwin's Legacy Alliance Outreach Program, modeled after Homeboy Industries from Southern California. The program currently serves 70 to 100 individuals who have been previously incarcerated. He expressed his hope of finding a way to preserve the program's mission and continue its valuable initiatives within the community.

Chief Ferriera discussed being close to finalizing the CCP Plan, which he aims to present to the Board of Supervisors (BOS) on April 29 at 9:00 a.m. A draft of the plan will be circulated for your review and feedback in advance of the Board of Supervisors (BOS) meeting.



The June quarterly CCP meeting was canceled, and the District Attorney's Office and the Probation Department will present on their CCP-funded programs at the following CCP meeting in September.

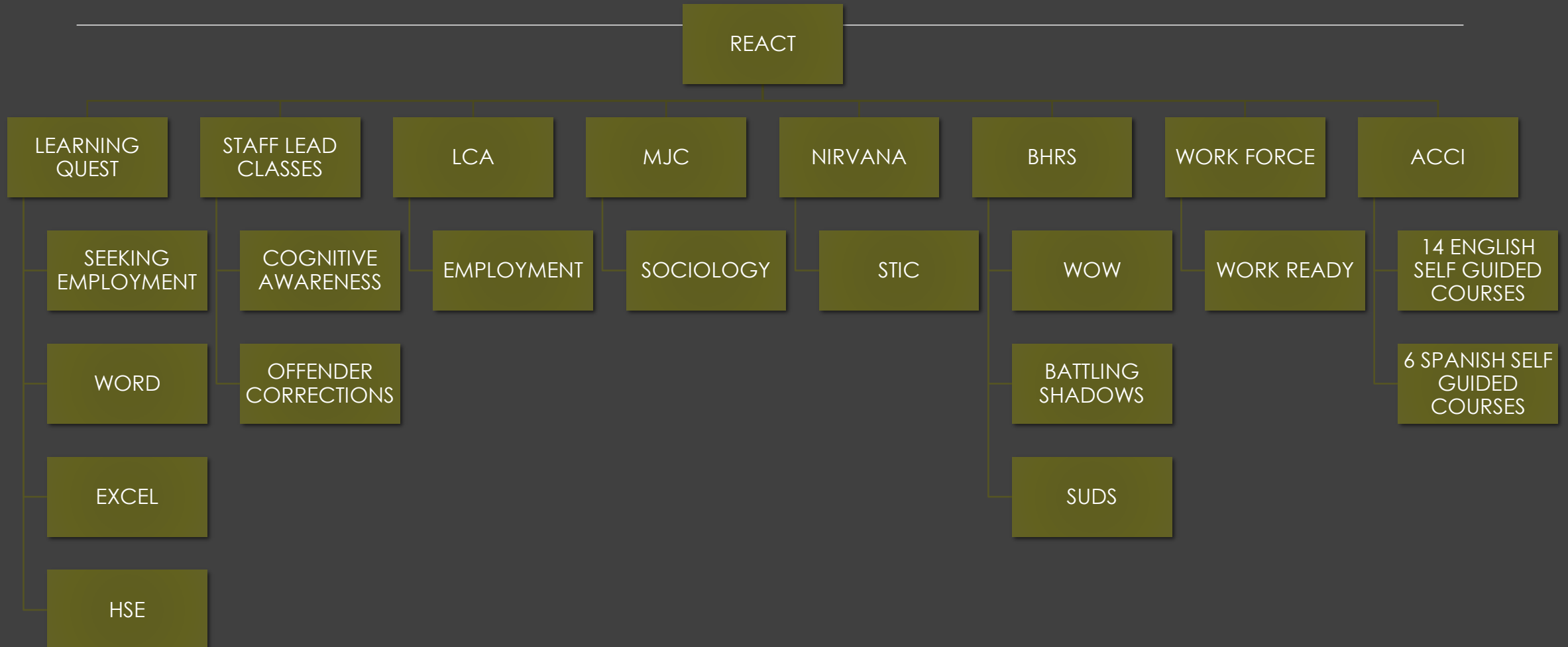

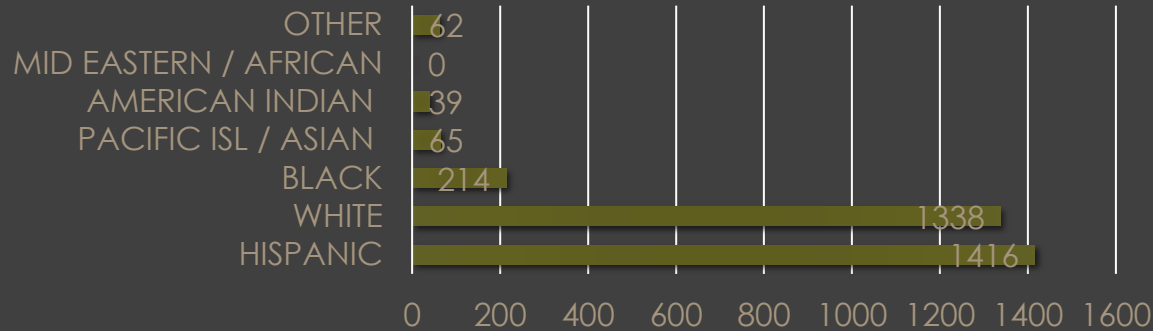

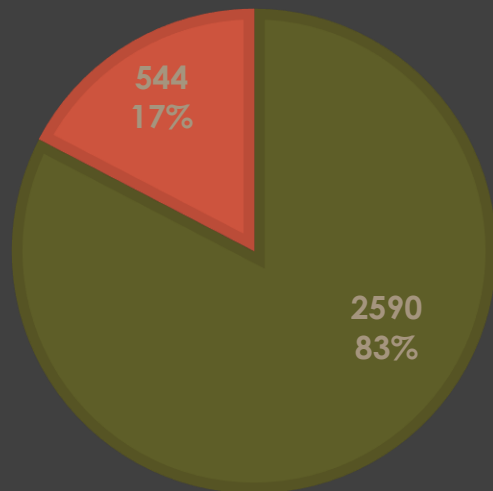

## RACIAL DEMOGRAPHIC



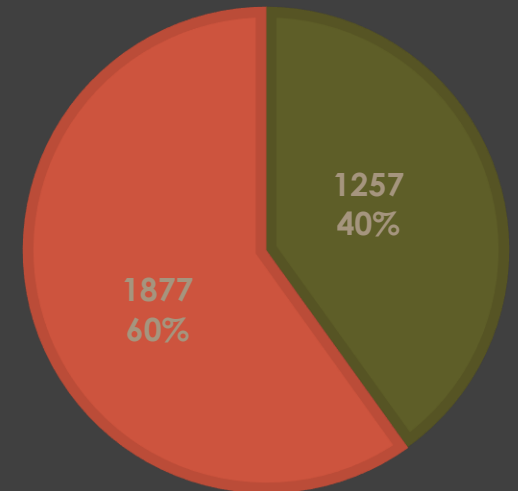

# 2024-2025 MJC HIGHLIGHTS



A PREVIOUS IP WAS A STUDENT OF THE FIRST MJC CLASS OFFERED IN THE FACILITY. SHE HAS BEEN RELEASED AND HAS CONTINUED HER EDUCATION AND SHE IS EARNING STRAIGHT A'S. SHE WAS RECENTLY HIRED BY RISE UP CENTER AS A STUDENT WORKER. SHE HAS JOINED THE RISING SCHOLAR CLUB THAT SERVES SYSTEM IMPACTED STUDENTS AND IS OFFICIALLY THE CLUB SECRETARY.

MJC INSTRUCTOR REPORTED "N2 has created a wonderful learning environment among themselves. A "teacher" emerged among them, and they have informal teaching sessions during the week among themselves. The teacher breaks down what I teach further to the others, giving them examples that are relevant to them. They have also had debates among each other. Students that struggle a little more have expressed how valuable this additional learning experience is for them. "



# 2024-2025 BHRS HIGHLIGHTS

A message from an Instructor:

"I have a client who was guarded in the beginning of the group. The Client has trauma from serving in the military as well as other traumas throughout life and has severe anger issues. The client was able to connect with the group facilitator through music. Once a trusting relationship began the client started to absorb the material from the battling shadows trauma group and was able to use it for his anger. The client took the group seriously and told other vets that the group was beneficial. The client continued utilizing the coping skills he had learned in the group. The facilitator would see the client using coping skills in the group such as the three-breath technique when he was getting frustrated with other group members. The client reports that this group has been super beneficial for his mental health. The client has now been serving as the mentor of the group after graduating. The client has been the mentor for months and continuously uses the tools from the workbook. The client now supports other group members in dealing with their trauma. The client has exhibited an openness to discussing the hard topics and being open to discussing his own experiences. Other group members have told me how helpful he has been and has even convinced some group members that this is beneficial. This client has worked with other group members outside of group to assist them with the workbook and help them understand how the different coping skills work. He has shown significant improvements since the beginning when he was guarded. "

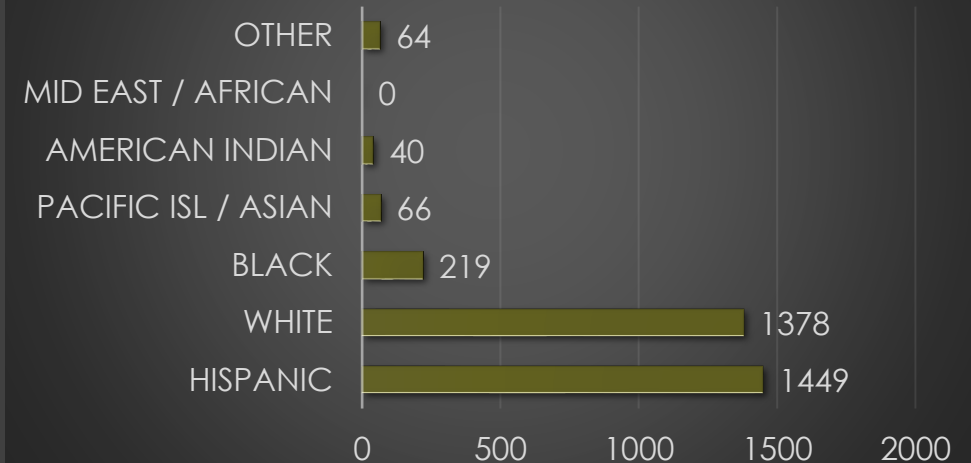
### AGE OF PARTICIPANTS

### RACIAL DEMOGRAPHIC OF PARTICIPANTS

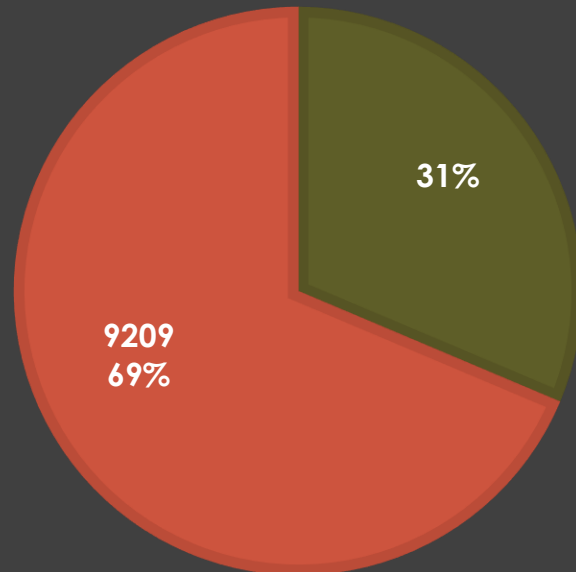

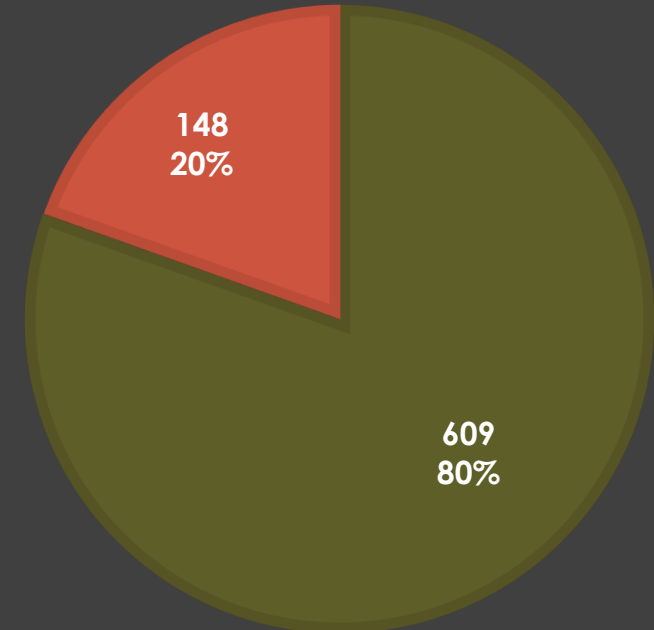
## RECIDIVISM ALL FACILITIES AFTER 7/01/2023 REGARDLESS OF PROGRAMING

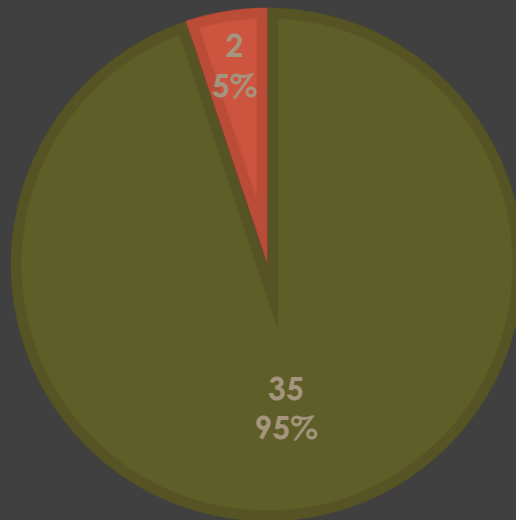

Enrollment by Month



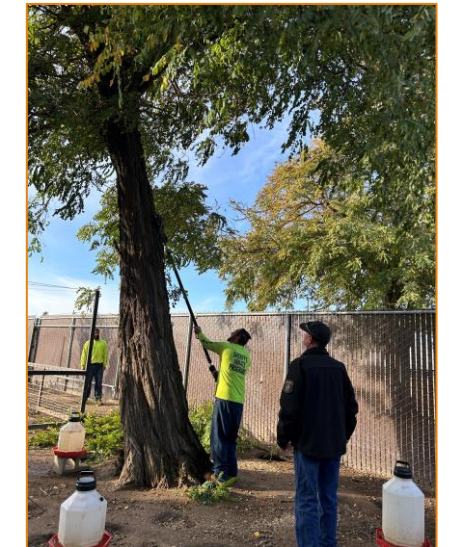
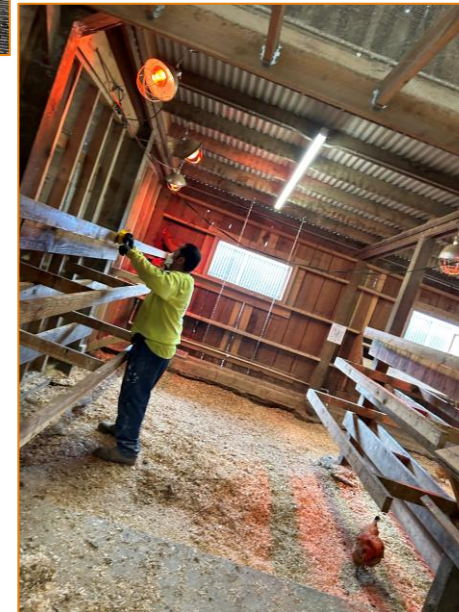
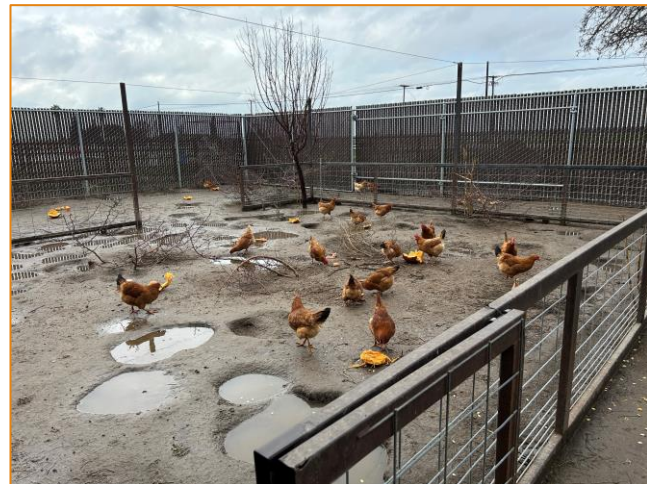
SUMMARY OF STUDENT ENROLLMENT

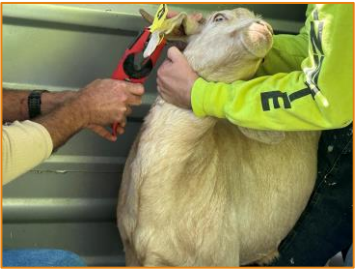

# About the Public Defender's Office:

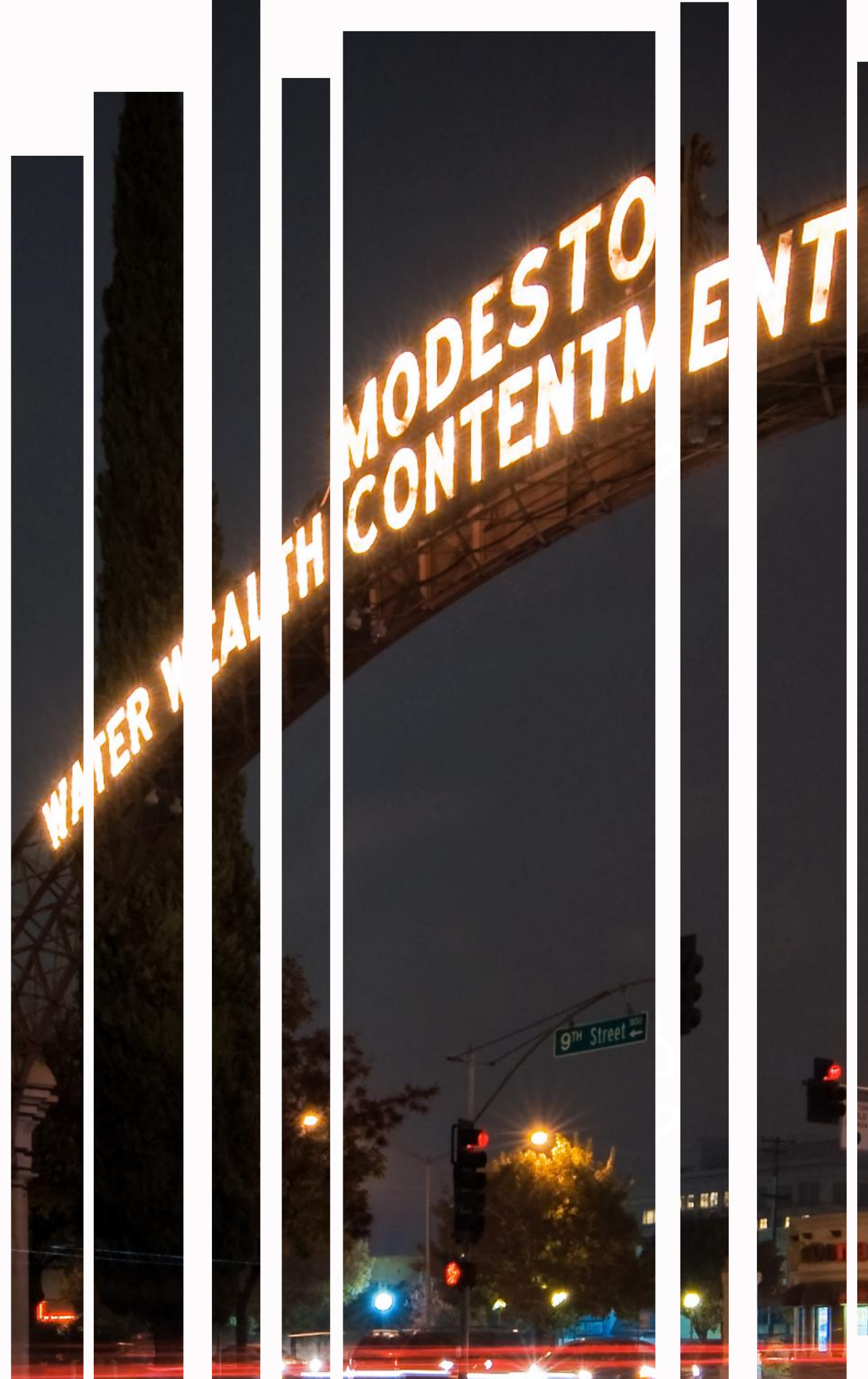

**Purpose:** access to counsel during the critical period after arrest & prior to arraignment.

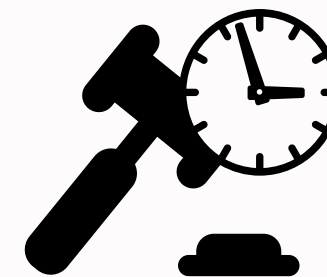
- Reach clients at the earliest opportunity

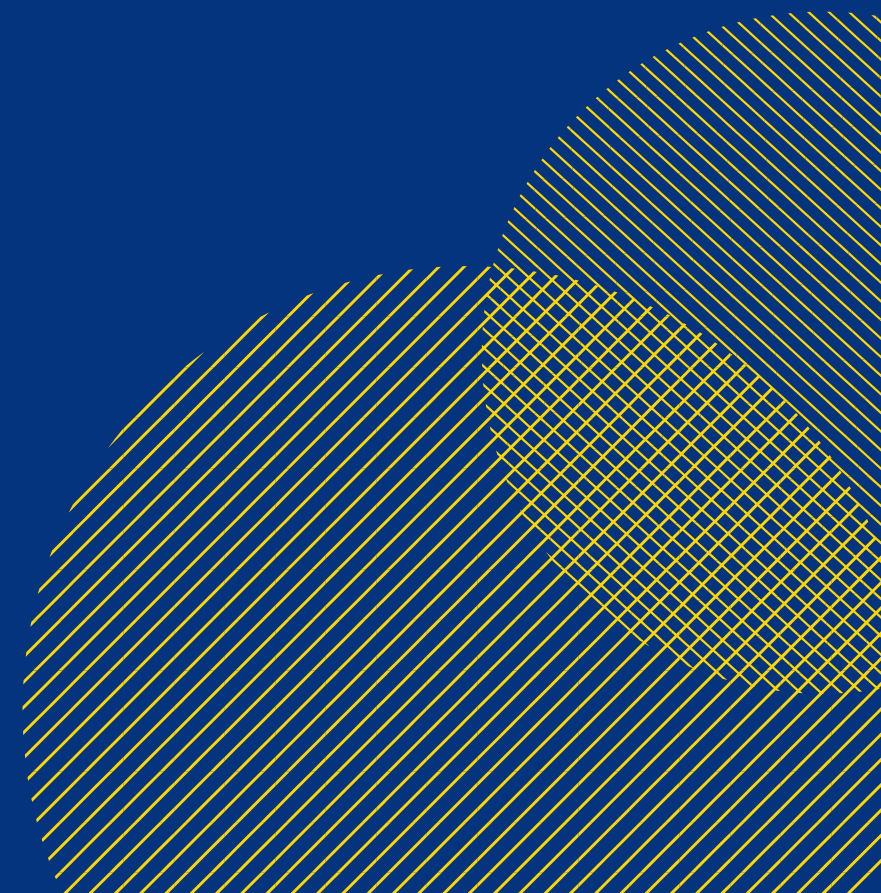

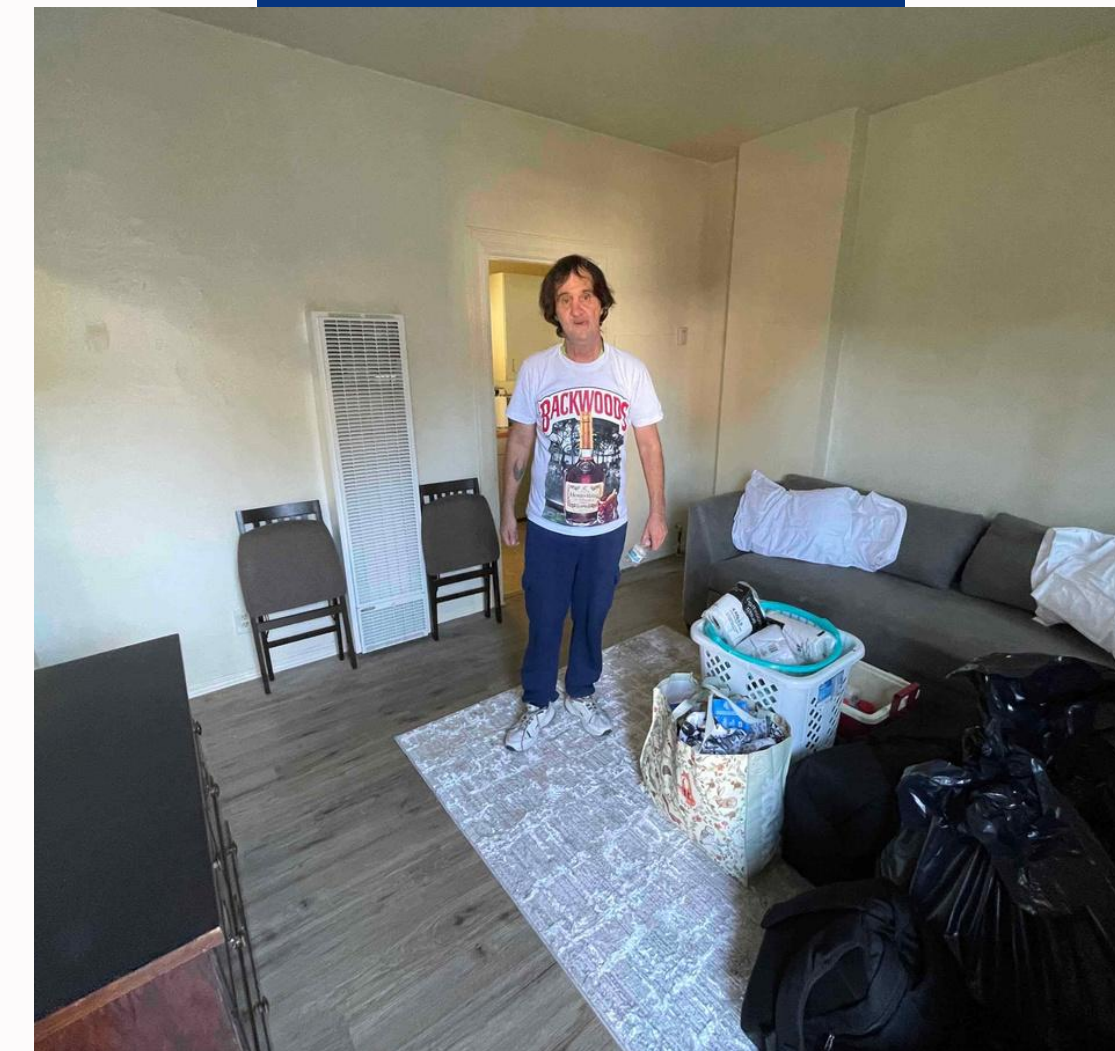
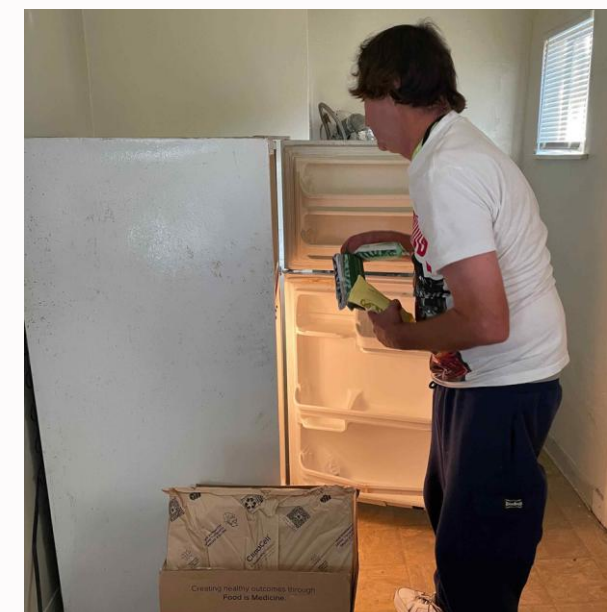

I also want to personally thank Mr. Martin Velasco and Neil Zientek for their help with meeting all my personal goals and obligations. They have been huge supports in my times of need. I've been battling my addiction for seventeen years and it has gotten me in and out of trouble with the law and I've sent to prison four times due to it. With this opportunity through the Veteran's Treatment Court, Probation Department, and the Public Defender's Office, I've been able to go to rehab, complete my PHP [partial hospitalization program] program, and am currently enrolled in an IOP [intensive outpatient program]. Due to the support I've received, I've managed to pull eight months of sobriety, which I had not been able to do on my own. Martin has been there every step of the way to help and guide me on my path to recovery and I am very grateful for the help he has given me. Now that I am sober and have a clear mind, I want to get into the career of helping others by possibly becoming a substance use counselor. I'm slowly getting back on my feet, starting with a safe and stable place to stay, and my family back in my life, and I now have healthy friends and relationships. Thank you again for being the support system that I needed to make this change.





# Mr. Angle

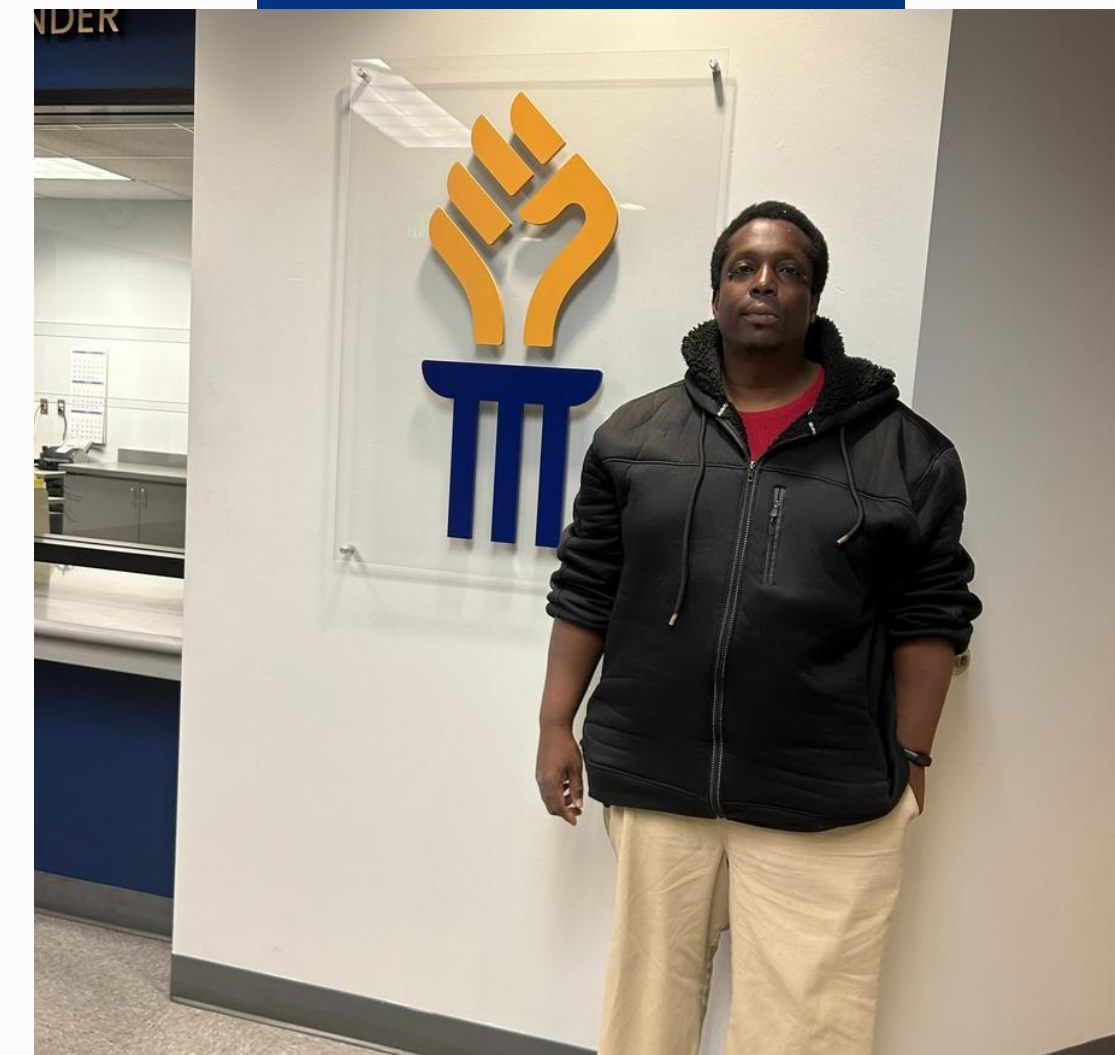

- Now, Willie resides in a room and board home in Modesto, where he has built a stable foundation for his future. He is connected to Turning Point's Full-Service Partnership, which continues to support his journey. No longer just surviving, Willie is thriving. He sets clear goals for himself—securing permanent housing, obtaining his driver's license, and eventually owning a car.
- Through it all, Willie stays true to his motto: "Stay in your own lane and take the necessary steps to be successful." And that's exactly what he's doing. His story is a testament to the power of resilience, support, and self-determination. Willie's future is bright, and he's driving toward it—one step at a time.

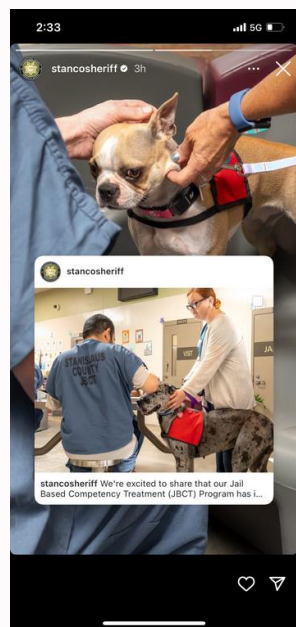
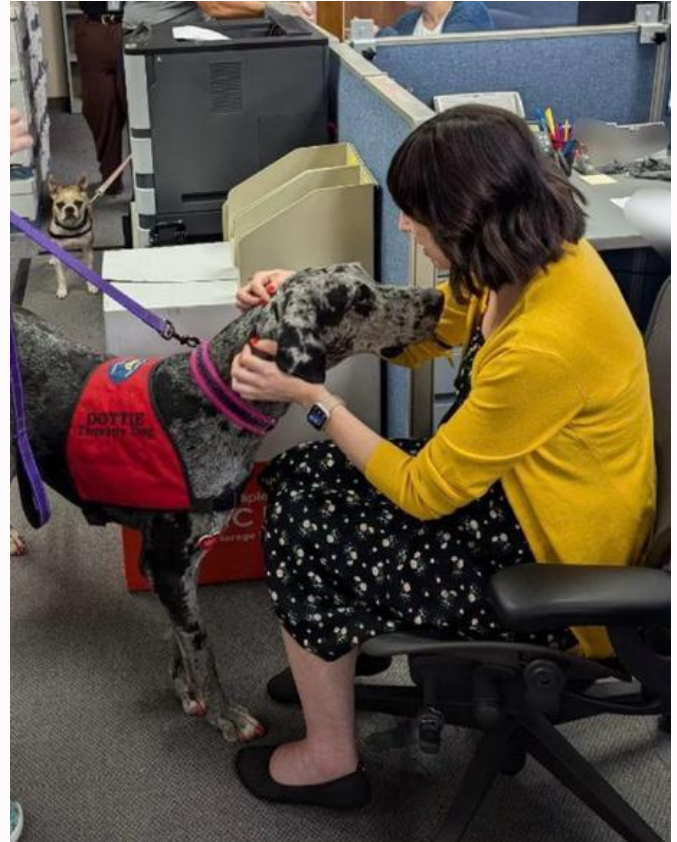
