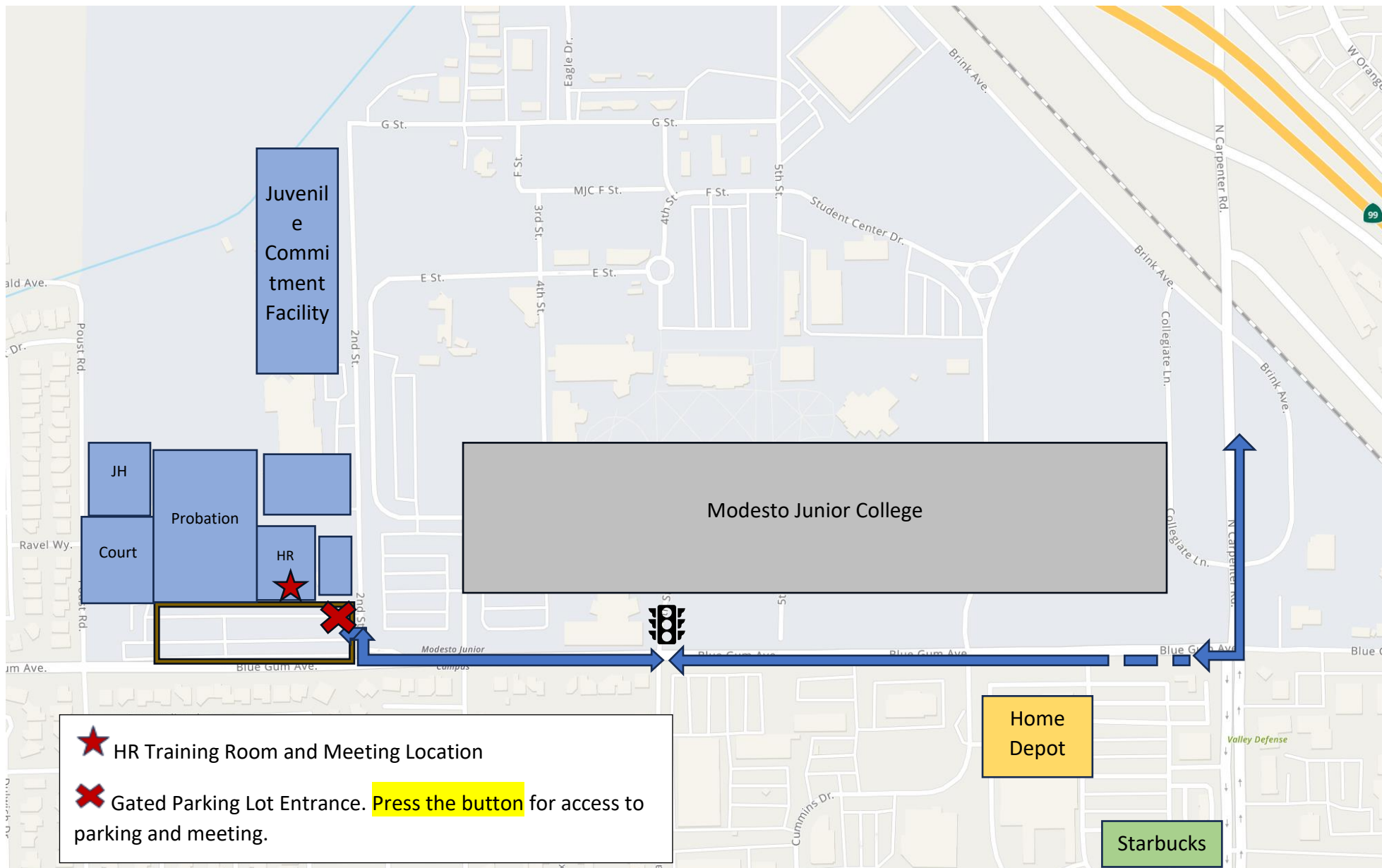

Call to Order: Lt. Fidel Landeros, JJC Chair, called the meeting to order at 12:00 p.m.

Public Comment: There was no public comment.

Approval of Minutes: MOTION: Marian Martino, SECOND: Jessica Godden. The minutes of the August 21, 2025, meeting were approved unanimously.

Consideration of Member Applications/Swear-in

The Juvenile Justice Commission (JJC) received applications for membership consideration from Mr. Antony Little and Ms. Fallon Ferris. Mr. Little introduced himself. Ms. Ferris was unable to attend today's meeting.

MOTION: Chairperson Fidel Landeros. SECOND: Craig Orona: This Board's recommendation to approve the admission of Antony Little into the Juvenile Justice Commission of Stanislaus County was approved unanimously.

MOTION: Chairperson Fidel Landeros. SECOND: Marian Martino: This Board's recommendation to approve the admission of Fallon Ferris into the Juvenile Justice Commission of Stanislaus County was approved unanimously.

The Presiding Juvenile Court Judge, Annette Rees, completed the swearing-in of Mr. Antony Little.

Announcements

Chairperson Fidel Landeros announced that inspections of the Oakdale Police Department and the Modesto Police Department are complete, and the reports have been submitted. The commission members present at today's meeting will participate in inspecting the Juvenile Institutions. He thanked the commission members for their participation in the inspections.

Finally, he mentioned that the JJC meetings for 2026 are scheduled, and Executive Assistant Eva Carrasco will be sending them to the JJC members.

Chief Ferriera briefly discussed AB 1376, which would limit wardship to 12 months unless extended by the court, noting that the juvenile justice system will be affected.

The next Juvenile Justice Commission meeting is scheduled for February 2, 2026, at noon.

The meeting adjourned at 12:38 p.m.
