I. **CALL TO ORDER**

The meeting was called to order at 11:45 a.m. by Assistant Chief Probation Officer Mike Hamasaki. Members of the group introduced themselves.

II. **PUBLIC COMMENT PERIOD**

No members of the public were present.

III. **APPROVE JANUARY, APRIL AND OCTOBER 2014 MEETING MINUTES: JJCC**

MOTION: Sheriff Adam Christianson. SECOND: Doris Foster. The minutes of the January, April and October 2014 meetings were approved unanimously.

IV. **REVIEW AND APPROVE PROPOSED MODIFICATION TO JJCPA PROGRAMS FOR FY2014-15: Mike Hamasaki, Assistant Chief Probation Officer**

ACPO Mike Hamasaki distributed a copy of the Stanislaus County Girls Juvenile Justice Initiative Evaluation Report (report attached to original copy of minutes) prepared by the National Council on Crime and Delinquency (NCCD). The Probation Department is proposing a modification to the JJCPA programs to include the Gender Responsive Alternatives to Detention (GRAD) program. The NCCD report highlights that the GRAD program has diverted 70 percent of the violations from going to Court with alternative sanctions. Two positions are funded through this program: a Deputy Probation Officer and a Case Manager from the Center for Human Services.

MOTION: ACPO Mike Hamasaki. SECOND: Sheriff Adam Christianson. The proposed modification to include the GRAD program in JJCPA funding for FY2014-15 is unanimously approved, pending approval through an e-mail sent to the Juvenile Justice Coordinating Council members not present at this meeting. One abstention from the voting was noted by Cindy Duenas, Director, Center for Human Services.

V. **APPROVE JJCPA PROGRAMS FOR FY2015-2016:** Mike Hamasaki, Assistant Chief Probation Officer ACPO Mike Hamasaki advised that the JJCPA programs for FY2015-16 will remain the same as those funded in FY2014-15 with the addition of the GRAD program. The October 2014 minutes were reviewed which reported on the outcomes of the JJCPA programs for FY2014-15.
MOTION: Natascha Roof. SECOND: Sheriff Adam Christianson. Continue to apply the JJCPA funding for FY2015-16 to the same programs funded in FY2014-15 with the addition of the GRAD program is unanimously approved, pending approval through an e-mail sent to the Juvenile Justice Coordinating Council members not present at this meeting.

IV. **ANNOUNCEMENTS**

Cindy Duenas, Director, Center for Human Services advised that referrals can be made to the Adolescent Substance Use Disorder Treatment group. This is an outpatient group for teenagers 13 to 17 years of age and meets for 1-1/2 hours each week.

V. **SUGGESTIONS FOR NEXT MEETING'S AGENDA**

Sheriff Christianson suggested holding the next JJCC meeting at the Sheriff Operations Center and the Council members will be able to tour the new Day Reporting Center.
