

Mr. Chapman reviewed the *Juvenile Justice Crime Prevention Act and Youthful Offender Block Grant – Combined Plan for Fiscal Year 2018/2019* (report attached to original copy of minutes) which outlined the JJCPA and YOBG funded programs/services/staff in FY2017-2018. He highlighted the following programs/services funded by JJCPA:

- Gender Responsive Alternatives to Detention (GRAD) will continue to be funded in FY2018-19 and includes a contract with the Center for Human Services.
- High-Risk Juvenile Offender Unit will continue to be funded in FY2018-19 with the addition of an Employment Development contract with County Workforce Development Department.
- Home Supervision – Electronic Monitoring/House Arrest program will continue to be funded in FY2018-19.
- Juvenile Drug Court will be re-designed with the assistance of a Mental Health/SUD Request for Proposal (RFP) for low risk, informal youth. The partnership with Juvenile Justice Mental Health (JMH) will be maintained for formal referrals for services/programs.

Mr. Chapman reviewed the following programs/services/staff funded by YOBG in 2017/2018:

- Home on Probation/JAIS assessment tool/Probation Supervision will continue to be funded in FY2018-19.
- Camp funding levels will continue to be funded in FY2018-19 with an increase in the Children System of Care (CSOC) contract to allow for assessments required for level of care placement.
- IT/Research Staff will continue to be funded in FY2018-19 with the addition of two new positions – one Sr. Developer and one Sr. Engineer. The case management system has been impacted with more information to be developed. Crime Analyst position will continued to be funded.
- Juvenile Hall will continue to be funded in FY2018-19.
- Youth Assessment Center – Planning Phase – New Category will begin a planning phase in FY2018-19 with implementation phase in FY2019-20. Cindy Duenas, Center for Human Services, discussed the Youth Court program offered in the past and the possibility of starting this type of program again. She noted that United Way funded this program in the past and it was an effective program for diversion.


- V. **PRESENTATION OF GIRLS ADVISORY COUNCIL – CONFERENCE IN MAY 2018: DPO II SABRINA BIONDO**
Division Director Dave Chapman introduced Renee Flora, Center for Human Services, who has been working on the development of the Girls Advisory Council with DPO II Sabrina Bionda. The Girls Advisory Council (GAC) was the result of the work of the Girls Juvenile Justice Initiative Task Force. The youth involved with the group have designed a logo and the GAC is sponsoring a conference for Jr. High and High School students on May 1, 2018. The conference is called “#Shetoo” and a flier has been developed and distributed (flier attached to original copy of minutes). Partnerships with various agencies in the community have been developed who are assisting with this conference to be held at Harvest Hall. Approximately 70 students from four schools have registered to date. Keynote speakers include Melanie Berru, a Sociology professor from Modesto Junior College who will speak on the topic of *Healthy Relationships and Domestic Violence*, and Jori Nunes, a Realtor, who will present information on *Childhood Hardship and Healing*. Peer-to-peer contact will be provided by HARRT, a youth led group, with activities and PSA. Breakfast and lunch are being provided. Agencies participating in the conference include Haven Women’s Center of Stanislaus, The Spot, PAL, She Became, Family Justice Center, Without Permission, Project YES and Josie’s Place. Mr. Chapman advised that an app is being developed with the 201 Project which will include information on how to access referral programs.
