# KIERNAN AVENUE AND HAMMETT ROAD INTERCHANGES



## Hammett Road Interchange

Widen Hammett Road from Ciccarelli Road to Pirrone Road, modify on- and off-ramps at State Route 99, and realign Pirrone Road within the project limits.

## Kiernan Avenue Interchange

Widen State Route 219 (Kiernan Avenue) between Salida Boulevard and Sisk Road, modify on- and off-ramps with State Route 99, and widen Salida Boulevard and Sisk Road within the project limits.



## WHAT IS THE PURPOSE OF EACH PROJECT?



The purpose of each project is to construct improvements to the State Route 219 (Kiernan Avenue) interchange and the Hammett Road interchange which will:

- Reduce congestion.
- Improve traffic operations at interchanges and local intersections.
- Accommodate forecasted traffic growth.

## PROJECT SCHEDULE\*

- January 2009 Environmental Studies Started
- **November 10, 2009 Public Meeting** 
- Spring 2010 Draft Environmental Document released
- Spring 2010 Public Hearing
- Spring 2010 Public Review Period Closes – Comments Due
- Summer 2010 Final Environmental Document Approved
- 2010-2012 Final Design
- 2010-2012 Right of Way Acquisition
- 2013-2015 Construct State Route 219 (Kiernan) Interchange Modifications
- 2014-2015 Construct Hammett Interchange Phase 1 Modifications

\* Project schedule is based on adequate accumulation of Development Impact Fees and other funds.

## WHAT'S NEXT

- Caltrans will complete Environmental Studies and issue a separate Draft Initial Study/ Environmental Assessment for each interchange project.
- A public review period of 30 days will be provided, and a public hearing will be held to obtain your input on the draft environmental documents.


