2026 OPEN ENROLLMENT

Welcome to the County's Annual Open Enrollment. The Open Enrollment period this year begins on Monday, October 13, 2025, and closes at 5:00 p.m. on Friday, October 24, 2025. Open Enrollment is your opportunity to enroll in health insurance or make benefit plan changes that best meet the needs of you and your family. Eligible participants are only able to enroll or make changes to their benefit selections for the 2026 plan year during these specific dates. New enrollments and changes will be effective on January 1, 2026.

This year's Open Enrollment is "passive," meaning the benefits you currently have will continue into 2026. Only submit a completed and signed enrollment form if you wish to make a change to your medical benefits for the 2026 Plan Year. Please note that future years may require active participation and the "passive" enrollment may change from year to year.

Medical Insurance

The Board of Supervisors approved no changes to rates for the County's medical insurance plans for 2026 with no change in plan design. The County will continue to offer a choice of the Exclusive Provider Organization (EPO) or High Deductible Health Plan (HDHP).

The IRS announced an increase to the inflation adjusted limits to the minimum annual deductible for High Deductible Health Plans (HDHP) mandated for 2026. The deductible for individual coverage will increase to \$1,700 and the deductible for family coverage will increase to \$3,400.

Your place of residence continues to determine the provider Network you will be assigned. If you live in the local service area, you will automatically be enrolled in the local Health Partners of Northern California (HPNC) network. All members who live outside the local service area will automatically be enrolled in the UnitedHealthcare (UHC) network. If you have moved, you are required to update your address information with earlyretirees@stancounty.com to ensure that you are enrolled in the correct health plan provider network based on your current physical home address zip code. A map of the local service area with applicable zip codes is included with this correspondence.

Review Your Beneficiary Designations Regularly, Please!

For your own peace of mind and the well-being of your loved ones, now is a great time to review your beneficiaries on your deferred compensation and health savings accounts, as well as any other personal accounts or life insurance you may have. It is essential for you to review and update the beneficiary designations on all your accounts on a regular basis and you may also want to check your beneficiaries whenever you have a major change in personal circumstances such as a marriage, divorce, birth or adoption of a child, or the death of a spouse, to ensure the information is both current and correct.
