## APPLICATION FOR A LICENSE OR RENEWAL UNDER ORDINANCE 6.08 BINGO GAMES

Per Stanislaus County Ordinance **6.08.040**: Organizations exempted from the payment of the bank and corporation tax by Sections 23701(a), 23701(b), 23701(d), 23701(e), 23701(f), 23701(g) and 23701(l) of the Revenue and Taxation Code and mobile home park associations and senior citizens organizations are eligible to apply to the county for the license to conduct bingo games in the county under the provisions of Section 326.5 of the Penal Code and the provisions of this chapter; provided, that the profits of such games are used only for charitable purposes. (Ord. NS 1095 §1, 1982; prior code §4-4(b)).

Per Stanislaus County Ordinance **6.08.050**: The license issued shall be for a term of one year from the date of issuance, subject to renewal and payments of the monthly additional fee as set forth in Section 6.08.280. (Ord. CS 559 §1, 1994; Ord. NS 1095 §1, 1982; prior code §4-4(c)).

Per Stanislaus County Ordinance **6.08.280**: In addition to the license application fee, a permittee shall pay a fee of one percent of the monthly gross receipts derived from bingo in excess of five thousand dollars. This additional fee shall be paid monthly to the treasurer-tax collector. The subsequent annual license renewal fee shall be reduced by an amount equal to the monthly additional fees that were paid during the preceding year, up to a maximum of fifty dollars.
